Lightweight and portable solution ready to use in few minutes. Made for audiometric testing in clinics,, hospitals, audiological centers and industrial environments. Equipped with reversible door with magnetic closure, universal module cable management tool table and external lighting.

On request, Pro25 can be equipped with pivoting wheels with brake (optional).

PRO 25 slim

PRO 25 slim is featured with a shorter side (74 cm against 97) and equipped as standard with pivoting wheels with brake to allow the passage through standard doors and smaller environments.

NOTE:

These data have been completed using the tables of noise reduction (Dp) of the cabin PRO 28 tested at the center studies and research C.S.I. of which we show an excerpt of the test report.

The complete file of the study on allowable the background noise is filed at PUMA s.r.l. offices.



Use and contraindications

- The soundproofing booth can be used only for audiometric or similar tests and not for other medical purposes with any parts applied to the patient (such as electrodes) where it is necessary to have different specifications.
- The booth must be always used in the presence of operation personnel.
- The operator who performs the test must always be in visual contact with the patient inside the booth.
- It is forbidden smoking or using naked flames inside the booth.
- The installation of the booth in unsuitable rooms or where there are flammable materials automatically disclaims any liabilities on the part of the manufacturer.

Equipment connection panels

The new connection panels allow:

- Direct contact between inside and outside booth equipments without further interruption or jack connection.
- The immediate replacement of equipment with different connections.
- The possibility to pass also with several cables.

Assembly



1) Remove the seal acting on the two Allen screws with the provided wrench.

The same operation must also be performed within the booth





2) Run the cables of the devices which are necessary such as headphones or anything else through the center hole.





3) Once introduced them let them fall and close again by positioning the seal (external and internal) previously removed and tighten

the Allen screws with the provided wrench.



4) Connect the designated equipment.

Connection cables for universal connection panels (optional)



Tripolar connection jack cables fully insulated allowing an immediate connection with the main audiometric instruments between the inside and the outside of the cabin.

To be used with the universal connection panels.

Reclining Table

Maximum load 12 Kg

The large reclining table allows to use a barely used space both inside and outside the booth.




Supported by two folding shelves, it can be easily opened. Just lift it until extending the support mechanism to the limit stop.





Do block the safety notches in their seats by pushing the table downward. Support locks must remain upright once entered into their seats.



To close the table lift it from the open position, manually help the rails to close by following through the table downward.







Maintenance and Cleaning

Routine maintenance:

The soundproof booth does not require any specific maintenance. The possible replacement of the broken lighting device can performed by trained personnel. (electrician).

Medical rooms maintenance and periodical verifications:

The maintenance of electrical systems should be committed to qualified companies which have the technical and professional requirements according to the DM 37 of 22.01.2008, art 4.

You should to perform audits of the systems, in particular you should check the efficiency of the grounding system every two years by measuring its resistance value. In particular, with reference to what is stated by the IEC 64-710, the medical room systems should be regularly checked by a trained technician. For this reason you should performs the following checks:

- measurement of insulation resistance according to IEC 64-8/6, at intervals not exceeding two years
- potential equalization at intervals not exceeding three years
- measurement of the resistance of the supplementary equipotential connection at intervals not exceeding three years
- the operation of safety power equipments according to the manufacturer's instructions and in any case at intervals not exceeding one year
- the efficiency of the grounding system at intervals not exceeding two years
- the efficiency of the electrical operation of residual current devices at intervals not exceeding one year

The tests and their results should be recorded in a signed and stamped register by the technical performer with the date of execution of the same.

Cleaning:

The outside of the booth can be cleaned as any furniture.

To clean the internal carpet and the fabric on the walls use specific products commercially available.

Warning:

- In case of power fuse replacement, the rated current of the device must not be greater than 6 ° gG.
- Don't block the ventilation fan when using the booth.






Assembly should be performed by trained personnel in furniture assembly always taking into consideration the drawings. Therefore, please read all instructions before proceeding.

Use the screws and the Allen key provided.




Standard base with adjustable feet






Base with wheels for Slim version



Installation inside hooks












Wiring
